## 2. Veterans Affairs (VA) Benefits

The Department of Veterans Affairs (VA) provides various benefits, including disability compensation, pensions, and healthcare, to eligible veterans. ### 3. Women, Infants, and Children (WIC)

The WIC program is a federally funded nutrition assistance program for low-income pregnant women, breastfeeding mothers, and children under five. It focuses on providing nutritional support and health education to eligible families. Since WIC is centered on food assistance and nutritional support, participation in our wellness programs typically should not affect your WIC benefits. However, each WIC office may have unique guidelines regarding program participation, so verifying with your local WIC office is always best.

### 4. Housing Assistance Programs (Including Section 8)

Section 8 and other public housing assistance programs help eligible individuals and families secure affordable housing. These programs may require that beneficiaries report changes in income, resources, or other forms of support. ## 5. Medicaid Waiver Programs
